રાજકીય અસ્થિતાનું સંકટ

હાલમાં જ બ્રિટનમાં ભારતીય મૂળના ધર્મપિ સુનક વડાપ્રધાન બનતાં દેશમાં કેટલાય લોકો ગૌરવની લાગણી અનુભવતા હતા, પરંતુ એ ભૂલવું ન બોધ્યે કે કોઈ વડાપ્રધાન માટે તેના દેશનું હિત જ સર્વોચ્ચ છે. આ જ સિદ્ધાંત રાષ્ટ્રવાદની આધારસિલા છે, જે વૈશ્વિકીકરણના યુગમાં પણ બદલાયો નથી. ભારતમાં રાષ્ટ્રવાદ વિવાદિત અવધારણા રહી છે. મોટાભાગે તેને ભાજપ સાથે જોડવામાં આવે છે. કારણ કે ભાજપનો વિરોધ કરવાનો અધિકાર અન્ય પક્ષો કે ભિન્ન વિચારધારાવાળા લોકોને છે, તેથી તેઓ ભાજપ અને રાષ્ટ્રવાદ બંનેનો વિરોધ કરવા લાગે છે. તેમને ચીન, જાપાન, અમેરિકા, જર્મની, ફ્રાન્સ, ઇટલી અને બ્રિટન વગેરેનો રાષ્ટ્રવાદ પ્રદેશાન નથી કરતો. જ્યારે વૈશ્વિક મંચો પર તમામ રાષ્ટ્ર પોષાણનાં હિતોને આગળ વધારવા રહે છે, ત્યારે ભારતની અંદરથી જ ભારતીય દૃષ્ટિકોણ પ્રત્યે વિરોધના સૂર ઊઠે છે, જેનાથી મંચો પર આપણો પક્ષ કમબેટ થાય છે. પરિણામે જનસંખ્યા અને લોકતાંત્રિક વ્યવસ્થાની દૃષ્ટિએ વિશ્વમાં સર્વાધિક મહત્વપૂર્ણ હોવા અને બ્રિટનને પછાડીને વિશ્વની પાંચમી આર્થિક શક્તિ બનાવવા છતાં સુરક્ષા પરિષદમાં ભારત સ્થાયી સદસ્ય નથી બની શક્યું. હાલમાં જ વિશ્વમાં ભારતને જે સન્માનિત સ્થાન પ્રાપ્ત થયું છે, તેનાનો અને ભૂદિહિજીવીઓને તેને સ્વીકારવામાં પણ અચકાટ થાય છે. તેમને લાગે છે કે તેનાથી ક્યાંક વડાપ્રધાન મોદી અને ભાજપને રાજકીય લાભ ન મળી જાય! તેની પાછળ શું કારણ છે? ભારતીય સમાજ આદિકાળથી જ સમાવેશી છે, જે પછાડી આવ્યું, તેને અહીં પ્રેમ અને સ્વીકૃતિ મળ્યાં. તેની પાછળ 'અતિથિ દેવો ભવ' અને 'વસુદેવ કુટુંબકર્મની ભાવના રહી, જે સંપૂર્ણ વિશ્વને એક પરિવાર રૂપે જુએ છે. આ મૂલ્ય આપણી સંસ્કૃતિની સાથે સાથે આપણી જ્ઞાન પરંપરા અને ઐદિહિકતામાં પણ વસેલાં હતાં. ભારત એકમાત્ર એવો દેશ છે, જેમાં સત્યના અન્વેષણ માટે ભારત કહેવાઈ શકે તેવાની સ્વીકૃતિ છે. તેથી રંગના-શુક સંવાદમાં કહેવામાં આવ્યું, 'વાદ-વાદે જાણતે તત્ત્વબોધઃ.' એટલે કે 'સંવાદથી જ સત્યનો બોધ થાય છે.' એટલે જ આજે પણ ભારતીય ઐદિહિક વિમર્શમાં એ જ સત્યની શોધ માટે વૈશ્વિકતા, વ્યાપકતા અને સાર્વભૌમિકતાને આગળ રાખવામાં આવે છે. રાષ્ટ્રવાદ જેવી અવધારણાઓ આપણને ભારતીય સંસ્કૃતિ અને જ્ઞાન-પરંપરાને પ્રતિકૂળ લાગે છે. આ જ ઉદારતા અને સહિષ્ણુતા ભારતીય સમાજની કમખેરી બની ગઈ, જેનાથી વિદેશી આક્રાંતાઓને ભારત પર આક્રમણ કરવા અને તેને પોતાના રાજકીય પ્રભુત્વમાં લેવાના પ્રયત્નો સફળ થતા રહ્યા, સાહે તે સિકંદર હોય, મુગલ આક્રમણોનો હોય કે અંગ્રેજો હોય! તેનાથી ભારતીય સમાજ સમગ્ર વિચિત્ર સંકટ ખડું થઈ ગયું. શું આપણે આપણી ઐદિહિક સંસ્કૃતિ, જ્ઞાન-પરંપરા અને તેનાં મૂલ્યોને બચાવીએ કે આપણી રાજકીય અસ્થિતાને? અને શું રાજકીય અસ્થિતાને બચાવવા વિના આપણે આપણી ઐદિહિક-સંસ્કૃતિ અને જ્ઞાન પરંપરાને બચાવી શકીએ છીએ?

અગાઉ પાલિકા, એસોસિએશન સર્વિસ ચાર્જ પેટે દેક્ષા વસુલતા હતા શહેરની ૬ સહીત રાજ્યની ૧૫૦ જુઆઈડીસી ૬બલ દેક્ષામાંથી મુક્ત, કરોડોની રહત

(એજન્સી) અમદાવાદ, રાજ્યની ૨૩૦માંથી શહેરની ૬ સહીત કુલ ૧૫૦ જુઆઈડીસીમાં કાર્યરત ઓધોગીક એકમો લાંબા સમયથી ૬બલ દેક્ષાસેશનના મુદ્દાનો સામનો કરી રહ્યા હતા. આ મુદ્દાને ગુજરાત ચેમ્બર ઓફ કોમર્સ એન્ડ ઈન્ડસ્ટ્રી જીસીઆઈ દ્વારા વર્ષથી સરકાર સમક્ષ રજૂઆત કરવામાં આવતી હતી. અત્યાર સુધી એકમો પાસેથી જુઆઈડીસી દ્વારા સર્વિસ ચાર્જ વસુલવામાં આવતો હતો તો બીજાતરફ આ ઉધોગો દ્વારા સ્થાનીકી સત્તા તંત્રને પણ દર વર્ષે દેક્ષા પેટે અંદાજે રૂ. ૪૦૦ કરોડ ચુકવતા હતા. જેનો સામે તેમને પુરતી માળખાકીય સુવિધાઓ મળતી ન હતી અને તેઓ અનેક મુશ્કેલીઓનો સામનો કરતા હતા. આ સમસ્યા અંગે તાજેતરમાં

હવે દરેક જુઆઈડીસીએ સ્થાનીક પાલિકા કે પંચાયતને જ દેક્ષા ચુકવવાનો રહેશે ગુજરાત ચેમ્બર ઓફ કોમર્સ એન્ડ ઈન્ડસ્ટ્રીએ મુખ્યમંત્રી અને ઉધોગમંત્રીને રજૂઆત કરી હતી. જીસીઆઈના પ્રમુખ પથીક પટવારીએ ઉધોગમંત્રી જગદીશ વિશ્વકર્મા સાથે બેઠક કરી આ બાબતની રજૂઆત કરી હતી અને ઉધોગોને તાત્કાલીક રાહત આપવા માગ કરી હતી. આ પ્રયાસોના પરીણામે નરોડા, વટવા જેવી ઓધોગીક વસાહતોમાં દેક્ષાની વસુલાત માટે અમદાવાદ મ્યુનિસિપલ કોર્પોરેશન દ્વારા અમલમાં મુકાયેલા મોડલને અન્ય જુઆઈડીસી માટે પણ અમલી કરવાનું નક્કી કરવામાં આવ્યું છે. જેના પગલે હવેથી માળખાકીય સુવિધાઓની જાળવણી માટે એક જ ઓધોગીક દ્વારા સર્વિસ દેક્ષા ઉધારવવામાં આવશે. જેમાંથી ૭૫ ટકા રકમનો ઉપયોગ જે તે જુઆઈડીસી એસોસિએશનના દ્વારા વિકાસ કામ માટે વાપરવામાં આવશે. જ્યારે બાકીની ૨૫ ટકા રકમ સ્થાનીક સત્તા તંત્રને અપાશે. આ નિર્ણયથી ગુજરાતના ઓધોગીક વિકાસ અને અર્થતંત્રને વેગ મળશે.

ગ્રામીણ વિસ્તારની મહિલાઓમાં હજુ પણ ઘરેલુ હિંસાની સમસ્યા યથાવત

(એજન્સી) ગાંધીનગર, દેશમાં કુલ મહિલાઓમાંથી ત્રીજા ભાગની મહિલાઓ કોઈપણ પ્રકારે ક્યારેક ઘરેલું હિંસાનો ભોગ બનતી હોવાનું તારણ છે. તેમાં ગુજરાત પણ પાછળ નથી. છેલ્લા કેટલાક વર્ષોમાં ગુજરાતમાં અનેક મહિલા ડોમેસ્ટીક વાયોલન્સનો ભોગ બની છે. પરંતુ કમનસીબે તેને ડોસ્પિટલમાં સારવાર માટે લેવાય ત્યારે તે આરોગ્યને લગતો મુદ્દો બની જતો હોય છે. જોકે વિવિધ એન્જઓ અને આશા બંદોનો દ્વારા આવી મહિલાઓને હવે ઘરેલું હિંસા સામે મહિલા સહાયતા કેન્દ્ર થકી મદદ પુરી પાડવાનો પ્રયોગ શરૂ કરાયો છે. રાજ્યમાં વન સ્ટોપ કાર્ટીસીસ સેન્ટર શરૂ કરાયા છે.

એક અભ્યાસમાં મહિલાઓને ફેક્ટરની ઈજાથી લઈને તણાવ હોવાનું તારણ તેમાં ગ્રામીણ મહિલાઓને મદદ માટે સ્વાતિ સંસ્થા દ્વારા ત્રણ હોસ્પિટલમાં મહિલા સહાયતા કેન્દ્ર શરૂ કરાયા છે. છેલ્લા કેટલાક વર્ષોમાં તેમના દ્વારા કરાયેલી કામગીરીના તારણો મીડિયાને જણાવતા સંસ્થાના અગ્રણીઓએ ઘરેલું હિંસાનો ભોગ બનતી મહિલાઓ અંગેના અભ્યાસ રજૂ કર્યો હતો. જેમાં આવી મહિલાઓ તેમના સુધી પહોંચે છે. તે માટે આશા વર્કરનો સહયોગ લેવામાં આવે છે. પાટણ જીલ્લાની ત્રણ જાહેર શેઠની હોસ્પિટલોમાં સંસ્થા દ્વારા કામગીરી કરાઈ છે. ૨૦૧૪ જેટલી મહિલાઓને સેવા અપાઈ હતી. છેલ્લા બે વર્ષમાં આશા બંદોનો દ્વારા ૬૦ ટકાએ ઘરેલું હિંસાની શંકાસ્પદ ૯૮૦ મહિલાને ગ્રામ સ્તરના આરોગ્ય અને સુખાકારી કેન્દ્રમાં મોકલી હતી. હોસ્પિટલ આધારીત આરોગ્ય સંભાળ કાર્યકરો દ્વારા રીફર કરાયેલી મહિલાઓમાં ઘરેલું હિંસાનો ભોગ બની હોય તેમાં આજ હોસ્પિટલોમાં ૪૦ ટકા મહિલાઓને ફેક્ટર ૨૩ ટકામાં આત્મહત્યાનો પ્રયાસ, ૮ ટકાનો માનસીક સ્વાસ્થ્ય વિકારને લગતી ઈજાઓ જોવા મળી હતી. આશા વર્કર તરફથી લોકલાયેલી બંદોનોમાં તણાવના લક્ષણ તેમજ વધુ જોખમ હોય તેવી ગર્ભાવસ્થાની સ્થિતિને પણ તેમાં સમાવેશ થતો હતો.

With 17 more shows added to 'Eras Tour,' Taylor Swift makes her biggest ever US tour

Los Angeles, Nov 12 (IANS) Singer Taylor Swift announced on Friday morning that she has added 17 additional dates to her 'Eras Tour' of U.S. stadiums, bringing the total number of gigs to 52. That amended number makes it her biggest tour to date, and one that could easily break her own record for a gross in North America, reports Variety. All of the newly announced gigs are in cities that were previously part of the tour, but with second or third nights added, and in one case, a fifth night. The tour's concluding stop at LA's SoFi Stadium is now a five-night stand. That well eclipses the 38 dates that Swift did in the

U.S. on her "Reputation" tour in 2018, which had a record gross of \$266.1 million on ticket sales of more than 2 million attendees. With this far bigger number of 52 shows, Swift is almost certain to break that "Reputation"-era record in 2023, even if she were to play at well under capacity, which probably isn't likely.

What's remarkable is how Swift has accumulated a record number of dates for a stadium tour without expanding the original num-
